Exchange students are not permitted to take core courses. Also, students should note prerequisite requirements for all classes. If students register for courses that have prerequisites, they may be requested to provide relevant documentation of courses taken at the home institution. If such proof cannot be provided, they may be removed from the course.

Once nominated by their home school, incoming students will use the University's online International Programs portal, M-Compass, to complete an application and provide the necessary documentation. https://mcompass.umich.edu/

Deadlines:

Required Documents: International Exchange Application, Affidavit of Financial Support, Financial Documentation, Passport Copy. See M- Compass for complete application requirements.

Language of Instruction:

English

Language **Requirement:** The University of Michigan requires students to have demonstrated proficiency in English. Minimum requirements as set by the University are:

IELTS: 6.5-7.0 range TOEFL (PBT): 600 TOEFL (IBT): 100

Language Courses:

Foreign language courses are offered at the undergraduate level. Please contact your home school's academic services office to ensure that taking a language course will fit into your academic plan.

Requirements:

Academic/Experience Exchange students should have completed basic core courses before coming on exchange and should note prerequisite requirements for individual courses. A home school transcript may be required to prove completion of prerequisites during orientation.

Full-time Workload:

Graduate students are required to register for a minimum of 9 credit hours to be considered a full-time student and fulfill F-1 visa requirements. Most MBA students take 9-15 credit hours per semester, and the maximum number of credits allowed is 18 per semester.

Undergraduate students are required to register for a minimum of 12 credit hours to be considered a full-time student and fulfill F-1 visa requirements. Most BBA students take 12-15 credit hours per semester, and the maximum allowed is 18 per semester.

Students' home institutions may have different requirements for your coursework at Ross. Please contact your home institution to determine their requirements.

Learning Expectations: Class format and evaluation vary. Examples of class format include lecture, actionbased learning, interdisciplinary, and team-oriented situations. Class sizes vary, but usually range between 20 and 60 students.

Exams:

Exams are traditionally in mid-late October and mid-late December during the Fall term and late February and mid-late April for the Winter term. However, this can vary by course. Please review the academic calendar:

Grading: Grade Policies and Scholastic Requirements

MBA

Ross School of Business uses a five-level grading scale for all MBA and MAcc students:

Excellent (EX): Performance that is of superior quality. No more than 25 percent of the students in a core course shall receive this grade.

Good (GD): Performance that exceeds all the standard requirements of the course. Pass (PS): Performance that meets all the standard requirements of the course. Low Pass (LP): Performance that minimally meets the standard requirements of the course.

Fail (F): Performance that does not satisfy the minimal requirements of the course and is deficient on significant dimensions. No credit toward the degree will be granted for the grade of "Fail," but the grade will be used to evaluate academic standing.

There are no Honor points associated with the grade designations and no grade point averages appear on transcripts. Some courses may be graded under other University school or college guidelines and some may be graded on a mandatory Satisfactory/Unsatisfactory, Pass/Fail, or Credit/No Credit basis.

Below are estimated costs for a single student for the 2015-16 academic year. Please note the 2015-16 estimated expenses and insurance costs will be distributed in July 2015.
