This full-time residential program kicks off in August with a week in Washington, D.C., at the EY Accounting and Public Policy Symposium. The STEM-designated curriculum offers comprehensive accounting and cross-functional business electives taken alongside MBA students, plus the option to add a new accounting analytics concentration that empowers students to navigate vital aspects of business strategy. Students experience purposefully designed career preparation to leverage their undergraduate education along with their newly acquired business acumen, helping them stand out in a competitive job market.

This full-time residential program, which starts in June, is STEM-designated and open to students with all levels of experience.
