



## **UCD** Quinn Internship Programme

The Quinn School Internship Programme provides students with an opportunity to put theory and skills learned in the classroom into practice during their degree.

We have partnered with a range of companies from multinational professional services firms to local enterprises, to offer internships across a range of business disciplines. Our partners have recognised the high calibre of students coming from the Quinn School and increasingly consider internship opportunities as a fundamental part of their graduate recruitment strategy.

The Internship Programme is an optional programme which is open to penultimate year students on the Bachelor of Commerce, BSc Economics and Finance and Bsc Business Analytics degree programmes.

During the Programme students will register for a year long online reflective module designed to enhance the learning opportunities available throughout the year. Assessment will be structured on the work-based learning experience during the 9-12 months placement. Successful completion of the internship will form part of the Academic Transcript.

International Student Co-Ordinators: The International Student Coordinator helps international students integrate, adjust and adapt to life in UCD and Ireland and finds ways to enhance the UCD student experience.

Peer Mentor: Life at a new University can be daunting. Peer Mentors are students who have already completed their first or second year of study in a similar area and understand what it is like to be a new student at UCD. They are students from your own programme and/or subject area and remember what it's like to come here for the first time. They use that experience, and the knowledge they have gained since, to help new students integrate and begin to develop a sense of belonging to their programme of study.



English Language Support: For some international students, language difficulties may be one of the challenges they encounter in a new academic environment. In the Quinn School, you will be able to attend support classes in academic English, free of charge. These are designed to help students in topics such as academic writing, public speaking, pronunciation and grammar.

Academic Writing Centre: The Academic Writing Centre strives to ensure that students are helped to communicate, structure and present their knowledge and ideas in a written format, and that their expertise and critical thinking skills are not diminished by either fear of, or difficulties with, aspects of the writing process.

Mathematics Support Centre: Quantitative Skills are an integral part of any modern business curriculums and the foundation for more advanced areas of study in finance, accounting or analytics. Recognising that students may need additional support to develop their mathematical skills, the University opened the Maths Drop in Centre as an informal tutoring service for students looking to enhance their maths skills.

The Global Business Route: you will study through English at one of our international partner universities/business schools before returning to UCD in fourth year, where you will focus on studying business and intercultural skills, with no language option.



## **BSc Business Analytics**

An option of Quantitative Business

There is a recognised skills shortage in business analysts in the international business environment. Business Analytics prepares students who would like to work in organisations that need to extract and understand meaningful information from big data.

Business Analytics is about making the best possible use of the huge volumes of data that are now created every day in every sector of business, from social media to traditional manufacturing. It's about processing that data to find the hidden patterns that can lead to insight, predictions and better decisions.

It involves the development and application of quantitative models and concepts to illuminate management issues and solve managerial problems.

This course helps to develop students to determine business strategy using the analysis and interpretation of data.

#### Is this course for me?

If you're analytical in nature and interested in computing or mathematics then the new BSc in Business Analytics programme will give you the skills to put your aptitude into practice. Those who enjoy work where top-to-bottom understanding is needed, objectivity is valued, and it's possible to prove that a particular hypothesis or approach is the best will enjoy this course.

#### What will I study?

In first year you will study introductory programmes in business analytics, business, mathematics, and computer programming. Many will be shared with students of other programmes, including the BComm and BSc in Economics and Finance.

In second year you will build on these subjects, with further computational and business modules, with some flexibility in your choices. In final year, you will take advanced modules, many with a focus on computational approaches to data, and again with the flexibility to choose modules.

#### **Entry Route:**

Flexible admissions policy is in place, with two routes of entry; one based on mature years (23 years of age on the 1st January of the proposed year of entry), life experience and academic aptitude and the second based upon matriculation. The former route of entry tends to be the most common one with the average age of students in the region of 32 years.

The admissions process may include an interview and a writing skills test may also form part of the assessment.
